





Shoreline Update

Mr. Davis provided an update regarding funding of Flagler County's Beach Renourishment projects. Flagler County will be applying for FEMA Cat B funding for the HDOA shoreline since FEMA Cat G application was denied. The Shoreline Committee would be in the process of interviewing consultants who are knowledgeable about grant funding.

Justification:

The Hammock Dunes shoreline is a vital component of Flagler County's coastal infrastructure, providing essential protection for residential properties and contributing significantly to the county's tax base. Recent erosion and storm events have created an immediate threat to public safety and property, necessitating urgent protective measures.

Scope of Work:

- 1. Beach nourishment and dune restoration along 10 miles of shoreline

- 3. All necessary rights-of-entry and agreements to indemnify and hold harmless the Federal Government will be obtained

We respectfully request FEMA's consideration of this critical project to protect our community and preserve vital economic assets in Flagler County.

Bitcoin and gold both popular

As investment assets

Price Performance

- Bitcoin has significantly outperformed gold over the past decade
- * Bitcoin's 10-year return: 26,931%
- ❖ Gold's 10-year return: 125%
- Bitcoin is showing potential for high growth, albeit with higher volatility

Properties

Bitcoin

- ✓ Limited supply: Only 21 million bitcoins will ever exist
- Decentralized: Not controlled by any central authority
- ✓ Immutable: Transactions cannot be reversed or tampered with
- ✓ Fast global transactions: Can be sent quickly anywhere in the world
- ✓ Permissionless: No authorization needed to use or build on the network

❖ Gold

- ✓ Durable: Resistant to corrosion and tarnishing
- Dense: One of the heaviest naturally occurring elements
